### **NDF Administration Limited - In Administration (the Company) NDF A Fixed Rate Growth Plan 5 and NDF A Assured Growth Plan 8**

As you are aware, Martin Ellis and I were appointed as joint administrators of the Company on 14 October 2009. I now write with more specific details concerning your investment.

Your investment matured on 9 October 2009. However, at the date of my appointment you had not received the proceeds, or you received a cheque to cover the proceeds but this cheque was not honoured, due to the freezing of the Company's bank account following the insolvency.

My appointment triggered a 'Primary Pooling Event' under Financial Services Authority client money rules. This effectively meant that monies were frozen in the client accounts until it could be established that all monies could be accounted for.

I have now completed the reconciliation process of the client accounts and am pleased to confirm that I have found no deficiencies or omissions.

I am now in the process of returning investments. Due to the large number of transactions required this may take a few days to complete.

If you previously gave instructions to the Company as to how the proceeds were to be returned (i.e. cheque/bank transfer) then these will be acted on and there is no need for you to take any further action. If you have yet to give any instructions, please confirm in writing where and how you wish the proceeds to be returned. Please send your instructions to the Company at the address below:
